

- The MPNP will accept test results from two English testing agencies International English language Testing System (IELTS) General and Canadian English Language Proficiency Index Program (CELPIP)-General (available in Canada only). These are the same agencies and tests used by Immigration, Refugees and Citizenship Canada.
- The MPNP will assess your language points based on your test results in terms of how they compare to Canadian Language Benchmark
